

#### CTR Advisor for Women's Trial

The Trial Commission is dedicated to improving the situation for women riding trials. We have been working for some time now, trying to find ways to ensure that the dialogue with the riders is as good as possible and that the sporting side of the event will be to the satisfaction of all riders, whatever their level. The idea of an expert advisor present at the events is one way to move towards this goal. The FIM Women's Commission (CFM) helped us out by allocating one of the most experienced riders, Iris Krämer, to this position. This deal was finalised during the FIM Conference Meetings in Geneva in February. She will attend the jury meetings, participate in the section inspections and act as a link between the FIM jury and the riders to ensure that everybody feels included and their opinions heard.



#### The 2010 Calendar

We have been working to have a better calendar that can reduce the travel distance, time spent and costs for the riders to follow both the World Championship and the European Championship. The key to this is to work on the two calendars simultaneously from the start. In this respect, we are not satisfied with the 2010 calendar, partly because we have too few organisers applying for events and partly because the calendars for 2010 were already fixed when we discussed this

# Prospects for the 2011 Calendar

At the end of March we had a meeting between the CTR commission president (Jean Marc Crummier) and UEM trial chairman (Dave Willoughby), FIM Sports Director Ignacio Verneda and your editor to find the best possible solutions for the 2011 calendar. I am unable to give you any details yet, as some small issues still have to be solved and the calendars approved. But I can tell you this: the meeting was very successful, both for the men and women.

One of the ideas that came up at the riders' meeting in September was to go back to organising WC and EC for women the same weekend, as we did some 7-10 years ago. This will reduce the number of journeys and the costs for the riders. As it seems now, we can manage that for 2011. If everything goes as planned, you can actually attend all WC and EC rounds (three each) and the TdN by only having to make three journeys (if you stay for the days between two weekends) - thanks to a good dialogue between riders and commissions.



# 2010 FIM Training Camps

So far, we have only received one application to host a FIM Women's Trial Training Camp. That is somewhat disappointing as I know a lot of federations and regions need to boost their efforts to facilitate women in motorsports, and trial is the perfect discipline. But the harsh facts are perhaps that trials in itself has a low priority in a lot of national federations. If you add that to the fact that the same federations often do not have any policy for promoting women's motorsports, we end up with a bad combination.

I told you at the meeting we had in September at the TdN that we are totally dependent on you riders to take your part of the responsibility to make Women's trial - your sport grow and prosper. How? By making yourself visible and demaning a higher priority. Ask,

talk, flatter, yell, beg, charm, demand. Join forces! Do what it takes! In our modern world, no modern man wants the world to think he is an old fashioned guy, suppressing the rights to gender equality.

Anyhow: The one Camp we have so far is the traditional German "Girlie Camp", open to riders of all levels and from everywhere. The dates are 9-11 August. For more info, email or phone Iris Krämer (German & English). See "Contacts" at the end of this newsletter.
